WHEREAS, the Declaration of Covenants, Conditions, Easements and Restrictions for The Grove at Harbor Hills was originally recorded at Official Records Book 1417, Page 710 of the Public Records of Lake County, Florida ("Declaration"); and

WHEREAS, the Declaration was completely amended and restated by the Amended and Restated Declaration of Covenants, Conditions, Easements and Restrictions for The Grove at Harbor Hills recorded at Official Records Book 1422, Page 2124 of the Public Records of Lake County, Florida ("Amended and Restated Declaration"); and

WHEREAS, the Amended and Restated Declaration was also completely amended and restated by the Second Amended and Restated Declaration of Covenants, Conditions, Easements and Restrictions for The Grove at Harbor Hills recorded at Official Records Book 3660, Page 835 of the Public Records of Lake County, Florida ("Second Amended and Restated Declaration"); and

WHEREAS, pursuant to Section 7.4 of the Second Amended and Restated Declaration, the approval of at least 75% of the Voting Members is required to amend the Amended and Restated Declaration.

NOW THEREFORE, it is hereby certified that the First Amendment to the Second Amended and Restated Declaration of Covenants, Conditions, Easements and Restrictions for The Grove at Harbor Hills amending Section 7.4 of the Second Amended and Restated Declaration, as set forth herein, was properly approved by the Voting Members at a Special Members' Meeting held on **June 10**, **2018**.

ARTICLE VII ENFORCEMENT OF, AMENDMENT TO, AND TERM OF RESTRICTIONS, CONDITIONS, COVENANTS, RESERVATIONS AND LIENS

7.4 <u>Term; Amendment</u>. The covenants and restrictions of this Declaration shall run with and bind the Property for a term of twenty-five (25) years from the date this Declaration is recorded in the Public Records of Lake County, Florida, after which time they shall be automatically extended for successive periods of ten (10) years each. This Declaration may be amended at any time by one of the following methods: (a) by approval of at least 75% <u>66%</u> of the Voting Members in The Grove at Harbor Hills, who are present and voting, in person or by proxy, at a duly called meeting of the Members as evidenced by a <u>certificate of amendment</u>, certification thereof by the Secretary of the Association which is recorded in the Public Records; or (b) by the execution and recording of an instrument evidencing the-amendment executed by at least 75% of the Voting Members in The Grove at Harbor Hills, which instrument is effective upon being recorded in the Public Records.
